Terms and Conditions

Promoter	Treasury Wine Estates Australia Limited (ABN 78 145 321 320), Level 8, 161 Collins Street, Melbourne VIC 3000.
Competition Period	12.01am (AEDT) on 17/01/2022 to 11.59pm (AEDT) on 28/01/2022.
Who can enter?	Only Australian residents who are aged 18 or over.
Who can't enter?	Directors, officers, management and employees (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition.
Where will the competition run?	The competition will run in the Penfolds restaurant (Restaurant) at the Australian Open in Victoria.

Qualifying Purchase	Any glass of Penfolds Grange at the Restaurant.
Entry instructions	To enter, you must, during the Competition Period: (a) make a Qualifying Purchase from a Restaurant to receive a wine bangle with QR code from that Restaurant (subject to stocks remaining); and (b) Scan QR code to visit the Website, locate the entry page and fill out and submit the online entry form, including by providing all requested information. The Promoter is not responsible if your mobile device/desktop is not sufficiently capable for the purpose of submitting an entry.
How many winners will there be and how will they be chosen?	There will be 1 winner determined in respect of this competition. The first valid entry drawn randomly from the entries received during the Competition Period will win the prize.
